From the UNM Retiree Association Legislative Committee:

We are beginning the 2nd week for the 56th Legislative session. The session opened the first week with some unexpected upheaval and changes to the old guard. Representative Javier Martinez, District 11-Albuquerque, was elected Speaker of the House, as a replacement for Representative Brian Egolf who decided not to run for office in 2022. Later in the day, Representative Patricia Lundstrum, District 9-Gallup, a 22-year veteran and 6-year chair of the powerful House Appropriations and Finance Committee was removed from her position and Representative Nathan Small, District-Las Cruces, replaced her as the chair of HAFC. Representative Meredith Dixon, District 20-Albuquerque, moved into Representative Small's former position as Vice Chair of the HAFC.

Both parties in the House of Representatives had a change of leadership. Seven new House leaders were appointed and all seven are new to their leadership roles. As previously noted, the new Speaker is Representative Javier Martinez. The other additions to the new Democratic leadership team are Majority Leader Gail Chassey, District 18 – Albuquerque; Majority Whip Reena Szczepanski, District 47-Santa Fe; and Majority Caucus Chair Raymundo Lara, District 34-Chamberino. On the Republican side, the leadership team includes Minority Leader Ryan Lane, District 3 - Aztec; Minority Whip Jason Harper, District 57-Rio Rancho; and Minority Caucus Chair Gail Armstrong, District 49-Magdalena.

Senator Mimi Stewart, District 17-Albuquerque, a retired educator, was re-elected as President Pro-temp of the Senate. Senator Stewart sponsored both Senate Bill 36, Contributions to the Educational Retirement, in 2022 and SB 42, Increase Ed Retirement Contributions, in 2021. Both bills passed and increased the state/employer contribution rate to our ERB pension fund.

During the first week of the session, time is spent with introductions, orientations, and filing or introducing bills, joint memorials, and resolutions. By last Friday, 284 pieces of legislation were pre-filed. UNM Retiree Association will be watching as our New Mexico legislators roll up their sleeves to tackle the issues facing education and retirees.

Committee testimony can be given via ZOOM and committee and floor hearings can be watched by the public via webcast.

- Thursday, February 16 Deadline for introduction (Note: a legislation, dummy bill can be introduced at any time.)
- Saturday, March 18 Session ends (noon)
- Friday, April 7 Legislation not acted upon by the governor is pocket vetoed.
- Friday, June 16 The effective date of legislation, not a general appropriation bill or a bill carrying an emergency clause or other specified date.
