From the UNM Retiree Association Legislative Committee:

Greetings UNM Retiree Association,

House Memorial 1, PERA and ERB Pension Benefit Structure, sponsored by Representative Joy Garratt, passed unanimously in the House Labor and Veterans' Military Affairs committee on Tuesday, January 23. Alfred Mathewson, UNM Retiree Association, Past President Elect, was asked by Representative Garratt to provide expert testimony. Representative Garratt was unable to be there due to another committee meeting but had an assigned proxy in her place.

Representative Miguel Garcia spoke favorably for such a study on the differences between the two pension plans and that it was needed. Representative Patricia Roybal Cabellero noted that the two pension plan benefit structures are legislated and protected by the New Mexico Constitution. Any changes to the benefit structure would usually only apply to future employees under each plan. Both Representatives Garcia and Roybal Cabellero serve on the Investment and Pension Oversight Interim Committee.
