Our dedicated Legislative Team is at UNM Day at the Legislature today. Here is an update from them:

Greetings UNM Retiree Association,

Tuesday marks the 2024 Legislative Session mid-point. The session ends at noon on Thursday, February 15. At this time, approximately 554 forms of legislation have been filed. More are sure to follow as the deadline for introduction of legislation approaches on Wednesday, January 31,

(Note: Legislation filed as a dummy bill can be introduced at any time).

House Memorial 1, PERA and ERB Pension Benefit Structure, sponsored by Representative Joy Garratt, will be heard today on the House Floor sometime after 11:15 am, when the House convenes. The New Mexico Association of Education Retirees (NMAER) has signaled it is supporting HM 1.

ERB:

SM 4, PERA and ERB Pension Benefit Structures

Sponsor: Senator Mimi Stewart

Synopsis: This bill requests the legislative finance committee to conduct a study on equalizing the pension benefit structures of the educational retirement board and the public employees retirement association, in collaboration with the interim committee that studies investments and pensions and the University of New Mexico Bureau of Business and Economic Research. <https://www.nmlegis.gov/.../memorials/senate/SM004.pdf>

Current Location: Awaiting a hearing date in the Senate Rules Committee.

HM 1, PERA and ERB Pension Benefit Structures

Sponsor: Representative Joy Garratt

Status: House Labor, Veterans, and Military Affairs Committee, (HLVMAC), HM 1 unanimously DO PASS, Tuesday, January 23, 2024.

Current Location: Scheduled to be heard in the House Chamber, Monday, January 29, 2024.

PERA:

HB 172, PERA Member Temporary Payment

Sponsors: Representative Joseph L. Sanchez

Synopsis: The bill recommends an appropriation of sixty-three million dollars from the general fund to the public employees retirement association for expenditure in fiscal year 2025 and subsequent fiscal years to provide adequate funding to cover the cost of the temporary, additional, non-compounding payments.

#### 2024 LEGISLATIVE SESSION CALENDAR:

- Tuesday, January 2 – Friday, January 12 - Legislation may be pre-filed.
- Tuesday, January 16 - Opening day (noon)
- Wednesday, January 31 - Deadline for introduction (Note: Legislation filed as a dummy bill can be introduced at any time.)
- Thursday, February 15 - Session ends (noon)
- Wednesday, March 6 - Legislation not acted upon by governor is pocket vetoed.
- Wednesday, May 15 - The effective date of legislation, not a general appropriation bill or a bill carrying an emergency clause or other specified date.
