
Objectives and Purpose


- ERB and PERA retirement plan contributions and benefits are determined by multiple variables: a) employee and employer contribution rates, b) required years of service, c) multipliers (e.g. 2.35% for current ERB), d) Final Average Salary period, e) COLA rates and conditions and (of course) f) salaries.
- Both ERB and PERA have made many changes to variables since 1958.
- This presentation compares ERA and PERA career contributions and lifelong retirement benefits for 'typical employees' for each plan.
- Comparisons are for 4 'cohorts' corresponding to periods of employment (1958-83, 1978-2003, 1998-2023, 2018-2048 (projected using current terms).
- Values (\$) are adjusted for inflation for comparability.
- Questions about fund performance, solvency and related questions are beyond the scope of the study.


Assumptions and Data


- Classes of employees included are Primary & Secondary school teachers (ERB) and Financial Analyst Advanced (PERA – chosen because of similar educational requirements)
- Employees were assumed to retire as soon as eligible.
- All hypothetical PERA employees considered in this analysis are in the State General Plan(s), and no other PERA plans are considered.
- Used blended male/female life expectancies for ERB members (and same expectations for PERA members for comparability).
- 2003-2019: Public Education Department and State Personnel Office annual salary data.
- 1958 2003: U.S. Census Annual Survey of Public Employment & Payroll data (provided by the State to the US Census Bureau). BBER checked data for consistency with State agency data for 2003-2018).
- Historical pension benefit data provided by PERA and ERB (contribution rates, multipliers, COLA rates).

Employee Contribution Rates









Employee contributions

- ERB employee contributions (EC) have exceeded PERA EC since early-1980s to present.
- With recent changes, PERA EC will slightly exceed ERB EC beginning 2024.

Multiplier

- The multiplier for ERB was increased from 2.0% for 1958 cohort to 2.35% for 1978, 1998 and 2018 cohorts.
- The multiplier for PERA was increased from 2.0% for 1958 cohort to 3.0% for 1978 and 1998 cohorts, and was reduced to 2.5% for the 2018 cohort.

COLA increases

- PERA COLA has been above inflation (e.g. 3% early-1980s-2013), whereas ERB COLA has been fixed to inflation.
- PERA retirees have received increases 2 years after retirement, compared to increases to ERB retirees at 65 years of age and at 67 years for the 2018 cohort.
- Thus, PERA employees have received COLA increases for an average of 31.7 years, compared to 20.7 years for ERB employees.

Three Worker Comparisons

- 1. Average PERA State Employee (ALL Classified and Exempt) ↔ Average Education Worker
 - Includes Elementary, Secondary, and Post Secondary workers.
- 2. Education Administrator-Operational (PERA) ↔ Average Teacher (ERB)
 - Minimum requirement of a Bachelor's degree in Education.
- 3. Education Administrator-Advanced (PERA) ↔ Average Teacher (ERB)
 - Minimum requirement of a Bachelor's degree in Education with preference for a Masters degree in Education – starting average salary higher than Operational position.
 - Over half of Elementary and Secondary teachers in U.S. have a Master's degree or higher in the U.S. (BLS, 2018)


Worker Type Comparison #1:

and


ALL Education Workers

Differential in Career Salary Earnings (Red) and Pension Benefits (Grey)




Comparison of Key Ratios and Program Parameters







COLA/Total Pension




Average Teacher (ERB)

Differential in Career Salary Earnings (Red) and Pension Benefits (Grey)




Comparison of Key Ratios and Program Parameters










COLA/Total Pension




Average Teacher (ERB)

Differential in Career Salary Earnings (Red) and Pension Benefits (Grey)




Comparison of Key Ratios and Program Parameters







COLA/Total Pension



Gender of State Employees

Women as % of Total Employment in Public Education and State Employment in U.S., 1964-2019 (BLS)



- Description of Based on national data from the Bureau for Labor Statistics dating back to the 1960's women have consistently accounted for the majority of Primary & Secondary workers, and this percentage has grown steadily, to 3 in 4 workers in 2019.
- Based on the national data, the majority of ERB members have been historically and presently are female.
- Among State employees nationally, males outnumbered females through the late-1980's but by the early 1990's women accounted for half State workers.

Conclusions

PERA has paid higher retirement benefits than ERB relative to contributions since the 1978 cohort.

- This has been true for all three worker comparisons e.g. all members, K-12 Teachers ↔
 Education Administrator-Operational, and K-12 Teachers ↔ Education Administrator- Advanced.
- O Differences were greatest for cohorts beginning 1978 and 1998, when PERA benefits relative to employee contributions were between 54% and 88% higher than those of ERB.
- Recent changes have been significant e.g. PERA multiplier reduced from 3.0% to 2.5%; Years of Service increased, in effect, from 25 to 30 years for both PERA and ERB.
- These changes have reduced the differences between PERA and ERB retirees, but under current terms PERA employees hired in 2018 will receive on average 17% more retirement benefits net of employee contributions.
- COLA payments have accounted for much of the difference PERA COLA increases have been consistently higher and kick in after 2 years (52 y/o, now 57 y/o) vs. ERB at 65 y/o (now 67 y/o).
